*The streets where footway parking is permitted on a permanent basis either fully (with 4 wheels) or partially (with 2 wheels) on the pavement are formalised with parking bay markings and appropriate parking signs erected according to The Traffic Signs Regulations and General Directions (TSRGD)2002.*

*It is the responsibility of the motorist to park in the marked bays only. Failure to do so may result in the issuing of a penalty charge notice (PCN)*

*The streets where footway parking is permitted on a temporary basis either fully (with 4 wheels) or partially (with 2 wheels) on the pavement motorists are advised to leave a minimum of 1.2metres clear space for pedestrians use on the footway. Any obstruction reported will result in the issuing of a penalty charge notice (PCN)*
